ALERT CONCERNING NEW LIBERAL AND RESTRICTIVE MEASURES IN PREPARATION

- Followed by an open letter to the French Conseil Supérieur de la Magistrature and the Syndicat de la Magistrature, who must finally wake up and intervene "in the name of the people" to re-establish the rule of law in accordance with the Constitution.

ARTIFICIAL CRISIS(ES) - OPPORTUNITY FOR A NEW TREATY TO LIMIT THE SOVEREIGNTY OF STATES - CONTROL BY PRIVATE INTERESTS - INFLUENTIAL BODY ACTING ILLEGITIMATELY BEHIND THE WHO...

What is being called into question here is not in any way a criticism of the obvious interest of any provision favourable to public health, but a denunciation of the perverse and not very transparent cleavage through which the implementation of a presumed process of progress is articulated, the serious consequences of which we have had some glimpses of in recent years.

The usefulness of taking action on this subject does not therefore lie in any response to be formulated in a consultation questionnaire, but rather <u>in</u> extracting this subject from the context of widespread corruption.

NOTICE TO THE PEOPLE of Europe, who are being forced into servility by a political institution whose non-elected and non-representative "decision-makers" are almost all involved in conflicts of interest, some in illegal interest-taking and some in passive or deliberate corruption, and whose elected members of parliament are not fulfilling their duty to defend the interests of their people for reasons that are just as obscure!

The obvious collusion between the European institutions, foreign interference and private interest pressure groups, combined with the medical hubris of sorcerer's apprentices who are as much criminals as their financial backers, constitutes a serious danger to freedom through mass control and threatens human beings through attacks on their physical and moral integrity.

While propaganda for war - and not for peace!!! - is occupying minds in the same context of collusion and corruption, these new ideological oppressions are being implemented surreptitiously, acting simultaneously on:

- * the removal of the Constitution of the Nation-States in favour of a European Constitution which, as things stand, would have all the characteristics of a totalitarian system.
- * the approval of a special status for the WHO, a global health dictatorship for so-called public health to which all governments would have to submit.
- * the coupling of the first two intentions, facilitating the imposition of digital identity and, through this technique which undermines freedoms and free and informed consent, the obligation to obey and submit to any experimentation on human beings.

We saw the beginnings of this programme evolve with the planned unfolding of the so-called Covid-19 pandemic.

1- The insidious pretext:

In May 2022, the 75th World Health Assembly launched a process [...] of amendments to the IHR through a working group of WHO Member States, [which] is expected to last until May 2024.

The idea is to strengthen the IHR based on the lessons learned from the COVID-19 epidemic, so as to be better prepared to respond to the next public health emergency of international concern (PHEIC). The IHR applies to all events likely to constitute a PHEIC, whether they involve biological or chemical agents or ionising radiation, or are of natural, unintentional (e.g. laboratory accident) or deliberate origin.

Please note:

The International Health Regulations (known as IHR (2005), for the year of its most recent revision) is a legally binding international instrument to which 196 States Parties, including all 194 WHO Member States, have committed themselves.

While there is no denying the value of the intentions behind such a programme, given the imperative need for transparency in its implementation, it is worth examining the context in which authority over the application of the IHR is exercised by the World Health Organisation, with the complicity of governments and institutions subject to pressure from illegitimate organisations that are not exactly working in the interests of the common good. "Strengthening the IHR on the basis of the lessons learned from the Covid-19 epidemic" is an idea that smacks of the most perfidious hypocrisy. We saw and endured the Covid scam, which had no other purpose than to use terror to impose injections of experimental products on guinea pig populations, which greatly enriched the pharmaceutical industry and its financial backers without any scruples about the criminal acts committed, in addition to a certain redistribution of thanks to corrupt politicians and technocrats.

The extremely serious facts with which we are confronted demonstrate the extent to which "health" as seen by the oligarchy is nothing more than a monstrous business affair with every possible compromise, and the so-called science that is obviously practised without conscience is a breach of trust, a swindle, so much so that the meanders of conflicts of interest define its objectives and the lines of conduct to be followed.

The "scientific industry", which should be compatible with the IHR under the guidance of the WHO, is opposed to the principle of medicine serving public health.

The following sentence is perplexing: "The IHR applies to all events likely to constitute a PHEIC, whether they involve biological or chemical agents or ionising radiation, whether they are of natural, unintentional (e.g. laboratory accident) or deliberate origin. "This is not the case, however, given that everything mentioned is the result of harmful man-made processes, that there is no regulation of the health precautionary principle, and that it is the same people who are funding both the events likely to constitute a PHEIC and the health experiments supposedly necessary to protect health!! Reference is also made to "laboratory accidents" in which biological weapons are manufactured in violation of the United Nations Convention on the Prohibition of the Development, Production and Stockpiling of Bacteriological (Biological) and Toxin Weapons and on their Destruction. 2- The fallacious narrative:

The research roadmap on the WORLD HEATH ORGANIZATION - COVID-19 Public Health Emergency of International Concern (PHEIC) Global Forum on Research and Innovation website is intended to express a premise that has no serious basis whatsoever, in that right from the start of the presentation, the argument developed bears witness to the continuity of the manipulation and lies operated on the occasion of the so-called Covid-19 codified pandemic; a pretext that led to a global health dictatorship with its cohort of liberticidal and criminal measures:

"Overview

In the first six weeks of the new decade, the new coronavirus, known as COVID-19, spread from the People's Republic of China to 20 other countries.

On 30 January 2020, following the recommendations of the Emergency Committee, the WHO Director-General declared the epidemic to be a Public Health Emergency of International Concern (PHEIC).

Faced with the urgency of this epidemic, the international community is mobilising to find ways of considerably speeding up the development of interventions. The WHO R&D Plan is a global strategy and preparedness plan for the rapid activation of R&D activities during epidemics. Its aim is to accelerate the availability of effective tests, vaccines and medicines that can be used to save lives and avert a large-scale crisis.

Global experts on COVID-19 met at the World Health Organization's headquarters in Geneva on 11 and 12 February 2020 to assess the current level of knowledge about the new virus, agree on crucial research questions that need to be answered urgently and on ways to work together to accelerate and fund priority research that can help curb this epidemic and prepare for future outbreaks.

The global imperative for the research community is to maintain a high-level platform for discussion that enables consensus on strategic directions, nurtures scientific collaborations and supports optimal and rapid research to fill critical gaps, without duplication of effort.

International wake-up call: The WHO is preparing a sneak attack in 194 countries! (4)

3- How can we have confidence in an organisation that will impose itself on all states, whose:

- The Director General (of the WHO), Tedros Adhanom Ghebreyesus, is the subject of complaints for crimes against humanity, registered with the International Criminal Court (ICC);
- The Director-General changed the statistical references determining a pandemic as a result of private funding;

The Bill and Melinda Gates Foundation is the <u>second largest contributor</u> to the WHO's biennial budget, and is poised to become the largest following the freeze on US funding. It is also, ahead of the United States, the main funder of the GAVI Alliance, the Vaccine Alliance. (Le Monde newspaper, audit of 24 June 2020) (5)

- the Director General was involved in a fraud that called into question the effectiveness of treatments used as first aid, including *hydroxychloroquine* and *ivermectin*;
- Agnès Buzyn, who has been in charge of multilateral issues at the WHO since 5 January 2021, while formerly Minister for Solidarity and Health in the <u>first</u> and <u>second Edouard Philippe governments</u>, surprisingly took measures just before the Covid pandemic was declared, by order of 13 January 2020 of the Director General for Health Jérôme Salomon, acting on the Minister's behalf, to classify *hydroxychloroquine* "on list II of poisonous substances"; (6)
- Most of the funding is provided by private interests (see above); private interests decide the fate of humanity!?!
- Scientists have conflicts of interest and are under the thumb of laboratories, which are the leading cause of corruption in the world;
- in context, the pretext of protecting populations from the international spread of diseases caused by viruses no longer has anything in common with a real public health policy when these viruses are human products, biological weapons, chimeras insidiously called "gain of function".

- genetic manipulation is the subject of experimental programmes authorised by States and institutions subject to BIG FINANCE, BIG PHARMA, BIG DATA... Apart from the essential fact that the representatives of the French state want France to be a "leader" in this field!
- Pandemics are programmed according to the above-mentioned cartel (Event 201...); in the revision of the International Health Regulations, the concept of a pandemic is not defined! What control do people have over the unlimited and arbitrary measures that can be taken by the Director General of the WHO?
- Iniquitous laws are being passed to subject people to these arbitrary measures, in violation of free and informed consent!
- The propagandist relays of this trust in such an organisation are controlled by corrupt individuals within a conspiracy of a large number of states, themselves subject to illegitimate agencies...

4- Useless and evasive speeches:

With all the evidence now pointing to the monstrous fraud, the government-controlled media, joined by certain networks and media outlets that claim to be whistleblowers or independent, are still talking about the management of the "Covid crisis", raising doubts about risky decision-making or uncertainties supposedly linked to scientific controversies, as if they were pleading for leniency for the people involved!

This doublespeak is part of a controlled opposition to the emergence of the truth, feeding the doxa and nourishing state terrorism by making the most of human tragedy.

Similarly, the affair of Von der Leyen's text messages should in no way influence the position to be adopted in denouncing organised gang corruption within a governance system that is in breach of the rules applicable to the staff of the European institutions. (7)

We must not get bogged down in illusory and superfluous debates, when the glaring reality of the Covid pandemic fraud encourages us to concentrate on denouncing crimes committed against humanity, including experiments on human beings. (8) (9) (10)

The current intentions of the programme to implement a health dictatorship by means of a WHO under the control of financial and commercial affairs unrelated to the general interest are obvious insofar as they will only perpetuate crimes against humanity. (12)

It is high time to put an end to all these criminal abuses by opposing without delay the programme of continuity of these new abuses and by activating a trial procedure for all participants in these criminal measures.

5- Legal inertia:

The many inconsistencies and convincing contradictions raised by the "COVID 19 pandemic" (among other abuses...) demonstrate the extent to which people have been deliberately made the victims of delusion, the hostages of a deliberately mafia-like plan whose aim is to take control of humanity by a minority of lawless "powerful people".

Commissions of enquiry have been set up in various American states and several other countries around the world.

Senator Ron JOHNSON is warning the sleeping public about the Covid Cartel: "We are going down a very dangerous road, planned by a group of people who want to take total control of our lives (...)". (11)

Curiously, France does not have the same enthusiasm for bringing the truth to light, other than through the demonstration of a few perceptive elements labelled "conspiracy theorists" for want of more serious opposing arguments by those subsidised by the official narrative!

Apparently, the army's description of itself as the "Great Silent One" would be more appropriate for the judiciary, given the insignificance of its role in acting in the interests of the people!

By its deafening silence, when it does not hand down some questionable decisions, we can legitimately think that it serves other interests!

"According to whether you are powerful or miserable, court judgements will make you white or black", wrote La Fontaine in "Les Animaux malades de la peste". Adriana Minchella, editor-in-chief of MemberShip by TourMaG.com, points out that "in the wake of the pandemic, this maxim comes at just the right time ".

The judiciary does not inspire much confidence, given the constant misuse and even violation of laws and rules of law, in addition to the recurrent trampling of the Constitution.

Yet all it would take is a courageous demonstration of good conscience to restore the beginnings of a return to confidence.

On the other hand, the population has now understood that it can no longer expect anything from the world of politics, and as long as the castes and the so-called politicians are above the law, living among themselves, with a persistent lack of transparency, no return to trust is conceivable.

At this stage, in the context of organised gang corruption with eminently criminal consequences that the population is suffering, the time has come not to lodge complaints between the population and the judicial institution, but to bring the population closer to a judicial institution that must regain its credentials.

Ladies and gentlemen of the judiciary, wake up and the public will support you. Do not allow a health dictatorship to be established within a totalitarian political organisation in the continuity of a criminal exercise that has been openly practised more particularly over the last four years. If you fail to examine the many ongoing complaints supported by the facts, and if you do not follow the government's imposed narrative and the iniquitous laws that serve only white-collar criminals, you will be taking a stand against the people by substituting criminal complicity for the need for justice.

It is from this observation, through the evolving awareness of numbers, that fear will change sides. The rogue "rulers" are alerted by the profusion of freedom-destroying measures that are being introduced in quick succession. They are hoping that these freedom-destroying laws will enable them to escape justice!
